B. DISCUSSION AND POSSIBLE ACTION TO APPROVE THE INTERGOVERNMENTAL AGREEMENT FOR SHARED SERVICES BETWEEN THE TOWN OF EAGAR AND THE TOWN OF SPRINGERVILLE (MAYOR STEVE ERHART)

Mayor Steve Erhart stated that we are going to take the items out of order so that the public can speak. I want to state that both towns have been looking into combining services. Eagar will be over the fire department and will report to the Eagar manager and Springerville will be over the police department and will report to the Springerville manager. We have done the same agreement that Taylor and Snowflake have done but modified it to Eagar and Springerville. We have met with Taylor and Snowflake to discuss the do's and don'ts of the agreement. Things we looked at when thinking about the shared services is does it make sense, does it provide better coverage, and is it economically responsible to our citizens if so, we have an obligation to proceed. There is a savings from the shared services that will help us be more competitive with wages. Going into the fiscal year we do plan on doing a wage assessment study. If anyone wants a copy of the agreement please see Kelsi and Jessica and they will get a copy emailed to you.

Jody Emerald stated that she is here to clarify some of the confusion regarding the merging of the departments. In the last two months we have had five police officers leave between Eagar and Springerville with a good possibility of two more leaving. Springerville Police Department is considered fully staffed at seven officers that serves a population of approximately 1700 people with Eagar being fully staffed with six officers with a population of approximately 4400 people. The total between the two towns is 13 officers that would make the department fully staffed we are currently at eight officers with one being a new officer this is half of what we need and affects public safety, emergency response time, and the safety of our officers. I am not opposed to the

merger however what are your plans to resolve the current staffing issues, and has anyone from the police departments been apart of the discussions of the merger. Another issue is having a police department that has to answer directly to a defense attorney that it is a direct conflict.

Mayor Erhart responded that there will be twelve sworn officers and are looking to hire lateral officers. Typically, we have been higher than the county but compared to Show Low and some other areas we cannot compete with them on wages.

Councilwoman Debra Seeley stated that to answer Jody’s question about the conflict that the Springerville manager will be over the police department and that the Eagar manager will be over the fire department therefore there will not be a conflict.

Eagar Attorney Brett Rigg stated that he is the defense attorney for Eagar and Springerville. That will not change and there will continue to be no conflict.

Brannon Eagar stated he wants to thank both towns for considering this merger and that it has been needing to happen for a long time. It won’t be easy at first but working together will be a better outcome.

Terry Shove stated that she attends just about every council meeting and the merger makes her happy. Both departments already assist each other and work together.

Steve Nicoll stated that he is grateful to see this happening that it has been a long time coming. Let’s work past the issues and move forward.

REPORT

Chancy Nutt, Finance Director reported to council that as of January 31st our current cap position is \$9,000,540. Butler Street project expensed approximately \$400,480 of the \$3,000,942 and on the park pond project we have expensed \$437,000 of the \$750,000 budget. We expect both of these projects to reach completion at the end of this fiscal year which ends June 30th which will bring our end of the year approximately cash balance at \$6,000,989. We have spent significantly on town wide improvements however our annual operating budget nets at approximately \$160,000 a month during the fiscal 2023.

B. DISCUSSION AND POSSIBLE ACTION TO APPROVE REQUEST FOR QUALIFICATIONS FOR AN ARCHITECT FOR THE RAMSEY PARK CDBG PROJECT

Britney Reynolds, Community Development Director reported to council we sent out RFQ's for an architecture for the Ramsey Park bathrooms. All the information about them are in your packet and they were the only ones that submitted for the project. We have to have an architect approved before March and the plans have to be done by September to stay on the timeline for CDBG funds. Total remodel will be done to the bathrooms and will hopefully be easier to keep clean and not be vandalized as often.

Bryce Hamblin, Town Manager stated that when COVID struck we lost our inmates and our parks and facilities kind of went down hill because we didn't have the manpower to maintain facilities the Rec Center is one of those that was not kept up on. There are several different organizations that use it with the Little League being the main one. Looking at the clay I don't think we have had proper clay which can be dangerous. One field has had about 50 feet of encroachment from the lawn, and we are going to reshape those and put down proper clay. There is an additive that is supposed to help with it blowing away so that hopefully it won't be gone by next year. They are located in Phoenix and are by far the best price I have reached out to the County to see if they will help us haul it up here and I am waiting on a response. Also, the new bleachers have arrived.
